

Waiver and Release of Liability

In consideration of the risk of injury while participating in volunteering at Blackberry Creek Farm Animal Sanctuary (the "Activity"), and as consideration for the right to participate in the Activity, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in the Activity and do hereby release and forever discharge Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary, located on 1170 Pinecroft Road, Colfax, California 95713, their affiliates, managers, officers, members, agents, attorneys, staff, volunteers, representatives, successors, predecessors, heirs, and assigns, for any physical or psychological injury including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may suffer as a direct result of my participation in aforementioned Activity, including traveling to and from an event related to this Activity.

I am voluntarily participating in the aforementioned Activity and I am participating in the Activity entirely at my own risk. I am aware of the risks associated with traveling to and from as well as participating in the Activity, which may include, but are not limited to, physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and death. I understand that these injuries or outcomes may arise from my own or others' negligence, conditions related to travel, or the condition of the Activity location(s). Nonetheless, I assume all related risks, both unknown and known to me, of my participation in this Activity, including travel to, from, and during this Activity.

I agree to indemnify and hold harmless Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary against any claims, suits, or actions of any kind whatsoever of liability, compensation, damages, or otherwise brought by me or anyone on my behalf including attorney's fees and any related costs if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary incurs any of these types of expenses, I agree to reimburse Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary.

I acknowledge that Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary and their directors, officers, volunteers, representatives, and agents are not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific activity or event on behalf of Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary.

I acknowledge that this Activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include but are not limited to those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, equipment, vehicular traffic and actions of others, including but not limited to, participants, spectators, volunteers, event monitors, officers, and/or producers of the event.

I acknowledge that I have carefully read this "waiver and release" and fully understand that it is a release of liability. I expressly agree to release and discharge Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary and all of its affiliates, members, managers, officers, agents, staff, attorneys, volunteers, representatives, heirs, predecessors, successors and assigns from any and all claims or causes of action, and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary for personal injury or property damage.

To the extent that the statute or case law does not prohibit releases for negligence, this release is also for neglige part of Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary, its agents, and employees.

In the event that I should require medical care of treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment or facilities occurs as a result of my or my family's willful actions, neglect, or recklessness, I acknowledge and agree to be held liable for any and all costs associated with recklessness.

This Agreement was entered into at arm's-length, without duress or coercion, and is to be interpreted as in agreement between two parties of equal bargaining strength. Both the Participant, _____, and Josh and Danielle Hanosh and Blackberry Creek Farm Animal Sanctuary agree that this Agreement is clear and unambiguous as to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this Agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed, and enforced as so limited.
